Teacher turnover in DC's public schools are among the highest in the nation, and the pandemic has made teaching even more challenging. What do you think can be done to address teacher turnover in DCPS?	
As a former classroom teacher and educator, we must do more to support the holistic needs of our teachers in the District. COVID-19 has further exacerbated the long-standing issues educators in the District have raised over decades. The State Board of Education has done some very through research and investigation into this issue, and there are also national sources of data and reporting to draw from. SBOE's reporting gives us the data we need to move forward into action. While teacher incentives and supports are critical, the issues are much deeper. I believe the Council, in partnership with the State Board of Education and agency partners, should convene a strike force to come up with recommendations and immediate actions to find long term solutions to address the issues of teacher turnover. The data collected and analyzed by SBOE should be foundational to the process, but the strike force must include various stakeholders. I believe following a model similar to the one used for the DCPS Student Assignment and School Boundary Review Process of 2014 would be a great to follow. The pandemic has highlighted the need to provide equitable student access to technology as part of a 21st-century education. What will you do to ensure DCPS supports comprehensive technology planning and funding to support student learning?	
A need for comprehensive technology planning and funding is a critical element of supporting student learning but COVID showed us just how important it is for our entire city. For years, advocates like Grace Hu and Digital Equity in DC Education have raised issues, and potential solutions, for solving digital equity and a need for comprehensive technology planning for District students and educators. As a councilmember, I will be a champion for increasing funding for comprehensive technology planning focused on students and within our communities. While we must focus on the aspects of student learning that are connected to schools, we know that access to technology throughout our city is essential. I would fight to ensure our incoming federal infrastructure dollars are focused on bridging the digital divide by strengthening our city's broadband access and make meaningful connections with local dollars and legislation — such as Councilmember Allen's Internet For All bill — in order to have a greater impact.	
DCPS school communities have concerns with the quality of building repair and maintenance including HVAC systems in older as well as newly modernized buildings. How can the Council address their concerns with DCPS facilities operations and maintenance?	
The Council must work to address the issues and concerns over DCPS facilities operations and maintenance by taking the following steps: The Council should also meet with DGS and DCPS at the end of each school year to get an accounting of the process for preparing school facilities for the upcoming school year. This annual meeting should include a checklist of what projects and service requests are needed to open school buildings for the fall and include a measurable timeline to allow for tracking of progress. Conducting more vigorous oversight of the COVID infrastructure dollar. Probing deeper into where the gaps are in the process between DCPS requests and how DGS executes on those requests. This might highlight areas where DGS needs more support for the functions they are responsible for with school facilities maintenance. Require DGS to create a repairs dashboard to provide transparency in the process and provide an opportunity for public accountability for all repairs and service request. This dashboard should also create a portal to capture service requests and needs in real time so that educators can reach out to get the maintenance support they need in a rapid fashion. I will be a champion for prioritizing and increasing funding for small capital projects that work to address issues like HVAC issues, leaky roofs, plumbing, and other facility needs which are issues of safety and quality of life. This step must also include stronger oversight of the process.

assignment patterns on this timeline. I am not sure, given we are already in 2022, this is a reasonable timeline for completion but I do	
agree the process should be initiated soon.	
Should DCPS have budget protections because of its responsibilities as the school system-of-right?	Yes
Comments: As a system of matter of right schools, DCPS has to have the ability to support whoever shows up, whenever they show up,	
so appropriate funding is key. We have tried for years to ensure the funding follows the student but that process does not always	
work. Budget projects have the ability to ensure system funding stabilization, which is critical.	
The DC Council transferred responsibility for school security in DCPS schools from MPD back to DCPS; DCPS will	
control its security guard contract this year; and MPD School Resource Officers will be reduced. How should the Council determine whether students are more safe and secure?	
Growing up I remember positive experiences of school resources officers in my schools. As an educator I also appreciated the positive presence school resources officers provided within my school building but I also know my personal experiences are not the experiences everyone has with school resource officers inside of school buildings. To ensure the safety and security of students in school I believe the Council MUST work to implement the recommendations of the Police Reform Commission's report. The Commission's report was released a year ago and gave recommendations on how to achieve safety in schools while also keeping our young people from a culture of over-policing. Some of the steps the Commission referenced in the report such as the Officer Friendly program, MPD youth advisory committee, and others are good steps but I do see promise in refocusing our training efforts with school resource officers to reshape the roles they can have in school environments. Additionally, I believe we need to provide safety for students through other methods such as social emotional supports, trauma-informed practice training for staff, increasing the number of school counselors, providing school based mental health supports and staff, and more. If we do not follow the roadmaps, such as the Police Reform Commission's report, to change our methods of training and refocus our efforts to prioritize safety, nothing will change. The Council MUST act on the Police Reform Commission's report, listen to the recommendations of community advocates and stakeholders who raised issues about the school security contract, and appropriately fund the supports schools need to increase student security and safety.

opportunity. Furthermore, two of the most important functions of the State Board lie in the two independent offices housed there -	
the Office of the Student Advocate and Office of the Ombudsman for Public Education. I believe those offices need to be supported	
through increased funding and staffing support to play an even larger role in supporting the needs of families in our public education
