Teacher turnover in DC's public schools are among the highest in the nation, and the	
pandemic has made teaching even more challenging. What do you think can be done	
to address teacher turnover in DCPS?	
As a former school teacher and educator for seven years I know how sad it is to leave the classroom.	
What led me to leave was the work schedule and the lack of support I was given my last couple	
years in teaching. Although my passion is still there, as a Councilmember I would listen to other	
teachers and do more for them that was not given to me. As Ward 3 Councilmember I would push	
for a workforce housing incentive so teachers can live in the District and not have to commute from	
Maryland or Virginia. I would also like to explore a flexible scheduling pilot program for teachers as	
the pandemic taught us that teachers don't actually have to be in the classroom to successfully	
teach children. I would also explore incentives around parking, as most of the schools in Ward 3 are	
overcrowded and parking is not relatively available, leading to the PTO and community members to	
provide visitor parking passes to teachers. The District government has to do a better job around	
parking for teachers. Lastly, I would incentivize teachers around management training and how to	
further their careers in education. We need to make the job more enjoyable and strengthen our	
teachers.	
The pandemic has highlighted the need to provide equitable student access to	
technology as part of a 21st-century education. What will you do to ensure DCPS	
supports comprehensive technology planning and funding to support student	
learning?	
As the next Ward 3 Councilmember I would work with my colleagues to make sure DCPS is planning	
and providing technology to all students. I would provide tough oversight, follow the money to make	
sure it is being spent on technology resources and make sure teachers have the resources they need	
to support student learning.

The three greatest fiscal challenges facing public education are at-risk funding, funding of special education and English language learner programs, and appropriate capital investments to reduce	
overcrowding in Ward 3 schools. I am laser-focused on the equitable opportunity for all students in he District of Columbia. We have not reached the point in DC where families can walk into any	
public school and know that their child is receiving a high-quality education. Although there have	
peen improvements in public education since Mayoral control, the achievement gap between black	
and low-income families and their white middle-class peers has only increased since the pandemic.	
would address these fiscal challenges by committing additional educational resources for at-risk	
children in low income areas, ensuring they have the proper funding they need to succeed, as well	
es investing in capital improvements that reflect our greatest needs. As Ward 3 Councilmember I will push for an increase in dedicated funding to support Special Education and English Language	
Learner students. As Ward 3 Councilmember I will advocate for increased funding for early	
ntervention programs that show long lasting outcomes, including reducing the needs for special	
education placement and preventing grade retention. I would also increase programs outside of	
school that increase the social interactions for students with special needs. Lastly, as it pertains to	
Ward 3, relieving overcrowding in schools by first exploring opportunities inside the ward where	
space is available. Ward 3 schools are overcrowded because of their long history of success. I will	
work to dedicate capital funds to provide every student with proper facilities that enhance their	
earning experience. I applaud our Councilmember for getting the Council and the Mayor to	
ourchase the old GDS property on MacArthur Blvd. NW and for the Mayor wanting to add a new elementary school to Ward 3. Although I don't think Hardy Park is the right location, utilizing existing	
City-owned property is a great first step to relieve overcrowding. We also need to explore unused	
office space or vacant buildings in Ward 3 that the city can repurpose into education centers for our	
public school students.

from school. The Council should determine whether students are more safe and secure by requiring	
OSSE to provide data on school attendance and behavior incidents while at school. That way the

should return to the previous model and put MPD school resource officers back in schools.
